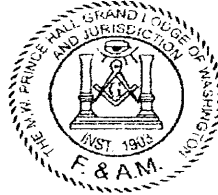


below, the acts will be judged by showmanship, costumes, artist likeness and overall moving of the crowd.

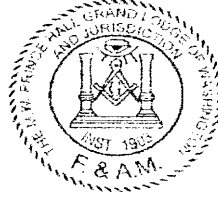
